MEMORANDUM OF UNDERSTANDING

Memorandum of Understanding between (

International Corporation for Humanitarian Services

(ICH)) And Association / Foundation (Charity Name)

Introduction:

Proceeding from the objectives of the International Humanitarian Services Corporation (ICH) "an institution specialized in providing contractual electronic services to the humanitarian associations and institutions sector, through marketing, supervision and follow-up of projects implemented by humanitarian associations and institutions, through the (We Help) platform, which is an electronic platform providing mediation services between associations and humanitarian institutions and those wishing to support the products of these associations and institutions. Based on the common desire between it and (an association/institution.....) specialized in financing and establishing humanitarian projects and wishing to benefit from the services it provides through its electronic platform, it was agreed between:

1. International Corporation for Humanitarian Services Ltd (ICH), a limited company registered in England and Wales, **registration number:** 11077577, **address:** 162-164 High Street, Deritend, Birmingham, England, B12 0LD, **represented by the electronic platform:** www.wehelp.uk, and **represented in signing this contract by:** Mr./ (Representer Name), **in his capacity as:** the General Manager, e-mail: info@wehelp.uk, and **referred to in this memorandum as:** (the first side)
2. An association/institution: (charity name), under a **commercial registry:** (commercial register number), its **address:** is a city (adreess), **Telephone:** (phone number), **Mobile:** (mobile number), **E-mail:** (mail), **represented in the signature of this memorandum as:** (second party name) **referred to in this memorandum as:** (the second side).

In accordance with this preamble, an understanding has been reached between the two parties, who are in their full legal capacity, on the following items:

Article one:

The foregoing preamble is an integral part of this contract, complementing it and explaining its terms.

Article Two: Areas of Cooperation:

The two parties agreed to cooperate with each other on the condition that the first party provide services through its electronic platform (We Help), which is represented in marketing and managing humanitarian projects that the second party is implementing.

Article 3: Duration of the memorandum:

1. The term of the memorandum is 3 years, starting from the date of its signature, and both parties have a review of their stance towards the memorandum at the end of the three years.

- 2. The work is automatically renewed at the end of this memorandum by the end of its term, unless one of the two parties notifies the other in writing of his desire to end the work at least 3 months before its end
- 3. In the event of termination of the work of the memorandum, the existing joint programs will be completed, according to its provisions, until the end of those programs.
- 4. Work under this memorandum will not take place until after approval by the competent authorities from both parties

Article Four: Contract value, payment terms and method of payment:

The first party will implement the agreed services of marketing charitable and humanitarian products and providing advertising and marketing services and support in project management in return for its commission according to the following:

Article Five: Emergency Circumstances:

The second party is obligated in the event of the occurrence of the emergency circumstance or force majeure, for example, but not limited to wars, economic depression, epidemics and other pandemics, to submit a report to the first party on the project and the plan for dealing with it within ten days from the occurrence of this circumstance to avoid delays in the agreed time plan for the implementation of the project, The first party is obligated to take the necessary measures by notifying the supporter within fifteen days from the date of his notification; It is obligated to provide alternative solutions to the supporter in the event that the project cannot be implemented.

Article Six: Confidentiality of Information:

- 1. The two parties are obligated to maintain the confidentiality of what is stated in this memorandum and not to disclose it to others without obtaining the written consent of the other party.
- 2. The two parties acknowledge and undertake that in the event of a breach of this undertaking or the unlawful disclosure of confidential information, which may cause material or moral damage to the other party, the injured party shall have the right to

sue the other party legally, file a claim for compensation and other claims, and demand the application and implementation of penal and administrative penalties. and civil against it before the executive and judicial authorities and authorities in the United Kingdom.

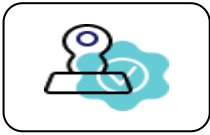
Article Seven: Copies of the memorandum:
